OUR ORGANISATION

Victoria University (VU) is a dual sector (higher education and TAFE) tertiary institution based in Melbourne, Australia. VU has academic colleges, each covering a broad discipline of study, and several research institutes and research centres. The University has campuses in Melbourne's CBD and western region, and a campus in Sydney. It also offers courses at partner institutions throughout Asia. Almost 43,000 students, including around 14,000 international students, study VU courses worldwide. In 2016, VU celebrated its 25th anniversary as a university, which also marked its 100 years as an educational institution.

ORGANISATIONAL UNIT

The University's Children's Centres have been developed to meet the needs of students and staff of the University and the boarder community. The University currently directly manages two Children's Centres, located at Footscray Nicholson, and Werribee Campuses. The University's Children's Centres are managed by Commercial Services.

 educational programs at the Centre in accordance with the Centre's procedures
- Participate fully in, and support the functioning of, the staff team.
- Assist in maintaining individual and group records related to children's programs.
- Understand and comply with employer policy and practices in all aspects of work and conduct, including OHS and antidiscrimination responsibilities and complete relevant training and attend staff meetings

TYPICAL/MAJOR CHALLENGES

- Comply with quality assurance policies and procedures, and other relevant legislative requirements applicable to the University..
- Supervise children in accordance with the Centre's policies and procedures, under the close supervision
 of the Coordinator and Diploma Qualified Educators.
- Seek direction from a Diploma Qualified Educator, the Children's Centre Coordinator and Educational Leader when addressing major decisions regarding the children and parents need to be made, including issues of concern regarding the welfare of children, the need for appropriate referrals or intervention and the reporting of complaints or accidents.

LEVEL OF SUPERVISION

This position reports to and receives routine supervision from the Children's Centre Coordinator and Educational Leader and operates within the University policies, procedures, and guidelines.
