OVERALL PURPOSE

The overall purpose of the Senior Lecturer – Clinical Psychology is to chair and to teach into our postgraduate psychology programs including the Master of Applied Psychology (Clinical Psychology), Master of Applied Psychology (Community Psychology), and the Master of Professional Psychology. The incumbent will also teach in general and professional areas of the APAC accredited curriculum as required, and supervise research in the 4th year and postgraduate psychology programs. They will also meet the requirements to hold a Research Fellowship and conduct high quality research in an area of strategic strength to the University.

ORGANISATIONAL ENVIRONMENT

Victoria University (VU) is a dual-sector (higher education and TAFE) tertiary institution based in Melbourne, Australia. VU has eight colleges, each covering a broad discipline of study, six research institutes and seven research centres. The University has nine campuses in Melbourne's CBD and western region, and a tenth campus in Sydney. It also offers courses at partner institutions throughout Asia. More than 42,861 students, including around 13,500 international students, study VU courses worldwide. This year, VU celebrates its 25th anniversary as a university, which will also mark its 100 years as an educational institution.

VU's Strategic Plan, *The University of Opportunity and Success 2016 – 2020*, presents a bold and distinctive vision that will ensure the University maintains its market position within an increasingly competitive tertiary environment. The College of Health and Biomedicine (CoHB), a Senior Discipline College, comprises four program groupings: Nursing and Midwifery; Medical Sciences; Allied Health; Clinical Services. The College currently offers courses at undergraduate and postgraduate levels. The Psychology Discipline sits within the Program of Clinical Services and delivers undergraduate programs, postgraduate Masters degrees in areas of applied psychology, Masters by Research and PhD. The successful candidate is required to make a significant contribution to leadership, teaching and research within the CoHB in the discipline of psychology, and primarily in the area of clinical psychology.

The operations of the College of Health and Biomedicine/Psychology Discipline and this position are currently located at the Footscray Nicholason campus of the University. The incumbent will also be required to teach on the Footscray Park campus as required.

MAJOR CHALLENGES / FREEDOM TO ACT

This position reports to and receives broad direction from the Head of Program, Clinical Services, Professor Jenny Sharples, and operates within the University policies, procedures and guidelines.

A Level C academic will normally make a significant contribution to their discipline at the national level. They will make original contributions, which expand knowledge or practice in their discipline and make a significant contribution to research and/or scholarship and/or teaching and administration activities at undergraduate, honours and postgraduate level. They will also normally play a major role or provide a significant degree of leadership in scholarly, research and/or professional activities relevant to the profession, discipline and/or community and may be required to perform the full academic responsibilities of Course Chair of a large award program, or a number of smaller award programs of the institution.

MAJOR DUTIES PERFORMED

In performing the following duties the incumbent is required to comply with quality assurance policies and procedures, and other relevant legislative requirements applicable to the University.

The major duties performed are:

- 1 Develop and implement high quality and innovative teaching materials and practices across all levels
- 2 Participate in professional development activities and undertake scholarly review of teaching methods and practices
- 3 Conduct research in accordance with VU Research expectations for this level of appointment including publishing in high quality journals, seeking external research funding, mentoring ECR colleagues, and carrying out the duties as a registered principal supervisor of HDR students.
- 4 If not already held, complete the Graduate Certificate of Tertiary Education
- 5 Identify, assess, prioritise and control risks to the health and safety of staff, students, visitors and contractors to the environment arising from the operation of the area under their responsibility, and ensure that a safe system of work is developed and followed through appropriate training, supervision and monitoring in line with the annual OH&S Plan.

SELECTION CRITERIA

Essential

- 1 PhD in Psychology
- 2 Current registration with AHPRA and endorsement in Clinical Psychology, including demonstrated professional experience in the practice of Clinical Psychology
- 3 Evidence of successful academic team leadership at program, discipline or department level
- 4 Research capacity, demonstrated by peer reviewed journal articles and/or conference presentations in an area of strategic strength for the University
- 5 Experience in higher education teaching and curriculum design in psychology, and evidence of impact on learning outcomes at the unit and/or course level and innovative approaches to teaching and learning, including online and blended learning
- 6 Strong communication skills, which may be applied to build and maintain relationships with key stakeholders both within and external to the University
- 7 A deep understanding of Victoria University's student body and its educational needs
- 8 A current working with children check
- 9 Awareness of OH&S responsibilities and willingness to attend OH&S training as required
- 10 Willingness to commit to Victoria University's values, which are: always welcoming; always ethical; always shaping the future; and always together
